**Location:** Bardeen Road Course  
 Tektronix, Inc. Beaverton Campus – Beaverton, OR

**Directions:** Traveling North on Murray Blvd, turn right on Jenkins Road and then an immediate right onto Bardeen Road. Follow Bardeen till you see the start line. Traveling South on Murray Blvd: Turn left on Jenkins and an immediate right onto Bardeen. Follow Bardeen to the start line.

**Course:** Flat, paved 1k loop on sanctioned course. Race will be judged according to USATF rules

**Divisions:** Men/Women: Youth (18 and Under), Open (18-39) (40-49) (50-59) (60-69) (70-79) (80+).  
 Association Awards are 3 deep with 10-year age divisions. **Note: The Association Championship is being contested jointly with Racewalkers Northwest Developmental 10K and 10K 2-Person Relay. For relay entry, see [www.rwnw.org](http://www.rwnw.org).**

**Other Info:** Event volunteers are also needed – especially Lap Counters and water table personnel. Please contact Registrar for information. Training provided!
